STUDENT LEARNING AND ACCOUNTABILITY

Ms. Gauch, Associate Superintendent for Student Learning and Accountability, provided information regarding the 2009-10 school calendar. Each year, the Prince William County School Board approves a school calendar for the next school year. Guidelines for the calendar are found in Regulation 261-1. These guidelines were used to develop the calendar. The calendar was reviewed by employee groups, organizations, and councils prior to being submitted for approval. The calendar will be voted on by the Board at the December 17 meeting.

FINANCE AND SUPPORT SERVICES

Mr. Dave Cline, Associate Superintendent for Finance and Support Services, indicated that an adjustment is necessary due to the increase in enrollment, the carryover of FY 08 unencumbered bus replacement funds, new revenues and the increase in grant programs where notification to the School Division was after the approval of the budget. The increase in state basic aid revenue due to the increase in enrollment of 336 students over projection is an estimated \$3.7 million; however, the overall increase is reduced to \$102,186 due to the projected reductions in sales tax, VRS, and lottery revenues. These increases require Board of County Supervisors appropriation before the funds can be encumbered. A summary of the increases by source of revenue is as follows, and a detail list by individual revenue was shared with the Board: Federal \$2,415,256; Local \$1,799,360; State \$ 683,186; Total \$4,897,802.

Mr. Richardson made a motion, seconded by Mr. Trenum, that the Prince William County School Board approve the request to increase the School Operating Fund budget by \$4,897,802 and direct staff to prepare the appropriate documents to be forwarded to the Board of County Supervisors.

SUPERINTENDENT'S TIME

Dr. Walts shared that the office staff at Antietam Elementary School were featured on Channel 4's Morning Person spotlight on November 18. He shared the names of the schools in Prince William County that made the top 100 elementary schools of Northern Virginia by *The Washington Post*. He announced that he is reviewing position requests and all vacancies, and he shared the School Focus story on Math Investigations.

BOARD MATTERS

Ms. Ramirez made a motion, seconded by Ms. Lucas, that the Prince William County School Board approve revised Policy 273.01, Political Activities; new Policy 923, Commercial Advertising; and new Policy 951, Parental Involvement in the Schools.

Recorded Vote: Yes, Unanimous

Proposed revisions to Policy 295, Standards for Use of Telecommunications and Internet Technologies and the proposed deletion of Policy 295.01, Internet Web Site Privacy were presented to the School Board for information.

Ms. Covington made a motion, seconded by Ms. Lucas, that beginning in 2009 and every fourth year thereafter, Inauguration Day is a holiday for employees and students and President's Day is a school day in Prince William County Public Schools.

Mr. Lattin made a motion, seconded by Ms. Covington, to maximize options for counties that the Prince William County School Board add a legislative amendment to permit decoupling of residential and commercial real property tax rates so long as the decoupling will not increase commercial tax rates.

Mr. Trenum requested discussion of the following: decision points/drop dead dates on when we have to make a decision regarding the purchase of new textbooks and materials for curriculum changes (specifically the 5th grade Geography course and the Math Investigations roll out to grade 5); the impact of immediately freezing all new hire actions, with the possible exception of replacement teachers; and the pros/cons of raising the cap on the amount of budget a principal can roll over, and possibly removing the cap entirely.

Dr. Otaigbe requested that the Board discuss the roll out to the 5th grade Math Investigations program at an upcoming meeting.

Ms. Ramirez indicated that no discussion was necessary regarding teachers using personal leave preceding or following school holidays (specifically January 19, 2009) since the Board voted to make January 20 a holiday for employees.

Mr. Richardson made a motion, seconded by Mr. Trenum, that the Prince William County School Board approve the revised Charge of Authority defining the nature and scope of the mission of the Safe Schools Advisory Council.

Recorded Vote: Yes, Unanimous

Mr. Trenum attended the community meeting regarding the Yorkshire boundary changes. He thanked the boundary committee for the job they did. On December 8 there will be another community meeting at Signal Hill Elementary School for those who were unable to attend the first meeting.

Mr. Richardson was delighted to hear that out of the top 100 elementary schools in Northern Virginia nine schools were Prince William County schools. He congratulated Mountain View for earning the top rank in Prince William.

Ms. Covington congratulated Pam Gauch on her retirement; she attended the recent reception and enjoyed seeing many retirees. She thanked Food Services for an outstanding job. She thanked the students from Forest Park High School for emailing her about January 20 (Inauguration Day) being a holiday.

Mr. Lattin did not have any comments.

Ms. Lucas congratulated Ms. Gauch on her retirement and wished her the very best. Ms. Lucas shared that her schools are in need of Smart Boards. She would be interested in how we will be able to fund Smart Boards as well as technology in our schools. Ms. Lucas indicated there is a program offered through the Attorney General's office regarding Internet Safety Programs and Gang Prevention Programs. They offer resources and training for free. She appreciates Dr. Walts reaching out to see what we can do to partner with them. She thanked Mr. Cline for meeting with her and answering her questions. Ms. Lucas congratulated Ms. Covington for being asked to be the Grand Marshall for the Dumfries Christmas parade this year.

Dr. Otaigbe reminded parents and students that the middle school specialty schools are holding their information sessions. Middle schools focus on foreign language programs, International Baccalaureate programs and science and math. He highly recommends the traditional schools. The programs are challenging. The deadline for applying is February 13, 2009; information is available on the website at www.pwcs.edu.

Ms. Ramirez indicated there will be a financial aid night for those attending college on December 9, 7 p.m. in the auditorium at Forest Park High School.

Mr. Johns asked the status of the information on the traditional high school survey. Mr. Johns indicated that he did not want anyone to take his comments to imply that he thought Board members were acting in a partisan or political fashion regarding the Inauguration discussion. His concern was that the discussion in the community became politically motivated. Mr. Johns congratulated Ms. Gauch on her retirement and thanked her for all she has done. He indicated that we are facing serious budget times. Staff is working very hard on the situation and he indicated that we will all work together.

There being no other matters for Board consideration, Chairman Johns declared this meeting adjourned at 9:29 p.m.
