Updates

Armed Robbery Series *CASE CLOSURES – Following the justified homicide that occurred at a residence located in the 4100 block of Hoffman Dr in Woodbridge on July 22, detectives with the Prince William County Police Department's Violent Crimes Bureau, with assistance from our Federal partners at the Bureau of Alcohol, Tobacco, Firearms, and Explosives, were able to connect the firearm found in possession of the deceased to a recent armed robbery at the 7-Eleven located on Dale Blvd in Woodbridge on July 16. During the robbery, the lone suspect fired a round after forcing taking money from the business. No injuries were reported. The shell casing collected at the scene was compared to the weapon recovered at the July 22 homicide scene and was determined to be a match. Detectives have been investigating the robbery in connection to four additional robberies that have occurred at other 7-Eleven locations in the Woodbridge and Dumfries areas since late June as involving the same suspect based on the description, clothing worn at the time, and modus operandi (MO) observed in the incidents. The other robberies occurred at 7-Eleven locations on Fraley Blvd in Dumfries on July 5, where a shot was also fired, and locations on Cloverdale Rd on July 3, Darbydale Ave on June 29, and Minnieville Rd on June 28. Detectives became increasingly concerned over the robberies escalating after the suspect was found to have discharged a handgun during the two more recent incidents. Forensic examination of the shell casing recovered on July 5 is ongoing. Detectives have confirmed the shell casing is the caliber and from the same manufacturer as the previous robbery on July 16. At the time of the July 22 homicide, the deceased was wearing clothing that was also observed in the reported robberies. Following the investigations into this robbery series, all known evidence indicates the deceased was responsible for all five incidents. Due to the suspect being deceased, these cases will be cleared by exemption, death of offender. Currently, there is no other known connection to the robbery series and the Hoffman Dr homicide.

Armed Robbery [Previously Released] – On July 16 at 3:20AM, officers responded to the 7-Eleven located at 4800 Dale Blvd in Woodbridge (22193) to investigate a robbery. Two employees of the store reported to police that an unknown man entered the business and approached them at the counter where he then brandished a firearm and demanded money. During the encounter, the suspect fired a round into a nearby display case before fleeing the store with an undisclosed amount of money. The suspect was last seen fleeing on foot towards Delaney Rd. A shell casing was recovered at the scene. No injuries were reported. A police K-9 searched the area for the suspect who was not located. A similar incident was reported on July 5 at the 7-Eleven on Fraley Blvd in Dumfries.

Armed Robbery [Previously Released] – On July 5 at 4:02AM, officers responded to the 7-Eleven located at 18075 Fraley Blvd. in Dumfries (22026) to investigate a robbery. An employee of the store reported to police that an unknown masked man entered the business and approached the counter where the suspect brandished a firearm and demanded money. During the encounter, the suspect fired a round into the display case behind the counter before fleeing the store. The store was occupied by additional patrons at the time of the robbery, no injuries were reported. An undisclosed amount of money was reported missing. The only suspect description is an unknown race male wearing all black clothing.

Armed Robbery [Previously Released] – On July 3 at 2:23AM, officers responded to the 7-Eleven located at 14820 Cloverdale Rd. in Woodbridge (22193) to investigate a robbery. An employee of the store reported to police that an unknown masked man entered the store and walked around for a short time before approaching the counter. When the suspect approached the counter, he brandished a firearm at the employee and demanded money. The suspect fled on foot prior to police arriving at the location. A police K-9 searched the area for the suspect who was not located. No injuries were reported. An undisclosed amount of money was reported missing.

**Continuation from the investigative update on the previous page.*

Armed Robbery [Previously Released] – On June 29 at 1:14AM, officers responded to the 7-Eleven located at 14797 Darbydale Ave. in Woodbridge (22193) to investigate an alarm activation. An employee of the business reported to police that while near the back of the store, an unknown man entered the store and approached him. During the encounter, the suspect retrieved a firearm from his waistband and demanded money. The employee walked to the registers in the front of the store while the suspect continued pointing the gun towards him. The suspect fled the business on foot prior to police arrival. No injuries were reported. A police K-9 searched the area for the suspect who was not located. An undisclosed amount of money was reported missing.

Armed Robbery [Previously Released] – On June 28 at 2:45AM, officers responded to the 7-Eleven located at 14410 Minnieville Rd. in Woodbridge (22193) to investigate a robbery. An employee of the business reported to police that an unknown man entered the store and approached the counter. During the encounter, the suspect retrieved a firearm from his waistband and brandished it towards the victim before demanding money from the register. The suspect fled on foot for a short distance before getting into a dark colored sedan and fleeing the area. No injuries were reported. An undisclosed amount of money was reported missing.

Incidents

Brandishing (Machete) | Road Rage – On July 31 at 7:40PM, officers responded to investigate a road rage incident that was reported to have occurred in the area of Farragut Ct and Irongate Way in Manassas (20109) earlier that afternoon. The victim, a 34-year-old man, reported to police that he was involved in an argument with the occupant of another vehicle. During the encounter, a male passenger of the other vehicle exited the vehicle holding a machete. The man began waving the machete in the air before getting back in the vehicle and fleeing the area. No physical contact occurred between the two men and no injuries were reported. The investigation continues.

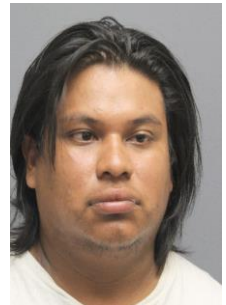

Commercial Burglary – On August 2 at 5:39AM, officers responded to Cricket Wireless located at 4377 Dale Blvd in Woodbridge (22193) to investigate an alarm activation. When officers arrived at the business, a rear door was found unsecured. Upon checking the business, several items were scattered about or missing. Video surveillance showed two men entering the business and removing items before fleeing. The suspects were only described as black men wearing dark-colored clothing.

Strangulation | Domestic Related – On August 1 at 2:40PM, officers responded to a home located in the 7900 block of Sharpsburg Ct in Manassas (20109) to investigate a domestic. The investigation revealed that the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation which escalated. During the encounter, the accused assaulted the victim and grabbed her by the neck. The parties separated and police were contacted. The victim reported minor injuries. Following the investigation, the accused, identified as Jose Antonio Reyes **MARTINEZ**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On August 1 at 3:40AM, officers responded to the 11700 block of Coleman St in Manassas (20112) to investigate a person walking on the caller's property. When officers arrived, they located a man, later identified as the accused, who was determined to be intoxicated. As officers went to detain the accused, he actively resisted which led to a struggle. During the arrest, the accused struck an officer in the face and kicked a second officer. The accused was transported to an area hospital due to his intoxication. The officers involved were not seriously injured. Following the investigation, the accused, identified as Damon Torianno **REPIQUE**, was arrested.

Attempted Commercial Burglary – On July 29 at 5:23PM, officers responded to investigate an attempted burglary that was reported to have occurred at the BP Service Station located at 8400 Sudley Rd. in Manassas (20109) at 10:20PM on July 28. The investigation revealed that two suspects utilized a fire extinguisher to damage the window in an attempt to gain entry into the business. Video surveillance footage revealed that the suspects fled on foot. No entry was made into the business. No property was reported missing. During the investigation, the suspects involved were identified. Officers obtained warrants for the arrest of both individuals, identified as Jesse Michael **ANDERSON** and Kayla Yvette **ELLER**, who were both subsequently arrested.
